With Reference to NPIU letter dated 21st January 2019 regarding establishment of competitive/collaborative research fund scheme under TEQIP-III RGPV invited research proposals from affiliated institutions and subsequently after evaluating the projects by the experts committee Hon'ble Vice Chancellor is pleased to accord the competitive/collaborative research fund under following terms and conditions --


1. The first instalment (one fourth of the total project cost) shall be transferred into to:
 - A. Departmental account (DOP) of concerned PI through PFMS in advance, if the PI is from UIT-RGPV.
 - B. The institutional account after confirming the institutional bank account, if the PI is from private affiliated institutions.
 - C. Furtherwards, funds shall be released on reimbursement basis.
2. The project are to be planned for completion by 31st march 2020 are maximum by 30th September 2020(if extension approved)
3. For any procurement in the Program, TEQIP Purchase guidelines (World Bank guidelines) will be applicable.
4. For competitive research fund, allocation up to 30% (out of estimated Rs. 3 lakhs) for equipment is allocated. GeM should be preferred for purchasing equipment. However, the equipment will the property of RGPV and shall be transferred to the affiliated private institutions by due procedure. RGPV will maintain the records of stock procured for physical verification.
5. No international travel is permissible. Only domestic travel is allowed for both PI and CO-PI along with accommodation.
6. **Expected outcome: PI will insure SCI indexed publications, development of innovative product/process, industry or societal relevant technologies under competitive/collaborative research fund TEQIP-III.**


